

EVENT INDEMNITY, ASSUMPTION OF RISK AND LIABILITY WAIVER

Event Organisers

This indemnity is entered into in favour of:

- Go Hiking SA
- Dlala Nje
- Ponte City Management
- Their directors, employees, volunteers, guides, contractors, agents, sponsors and representatives.

Declaration

I voluntarily choose to participate in this event and acknowledge that hiking, walking tours, stair climbing, sightseeing and associated activities involve inherent risks that may result in injury, illness, disability, death, loss or damage to property.

I confirm that I understand these risks and choose to participate entirely at my own risk.

Assumption of Risk

I acknowledge that the risks may include, but are not limited to:

- Slips, trips and falls.
- Uneven surfaces and stairways.
- Physical exertion and fatigue.
- Exposure to weather conditions.
- Medical emergencies.
- Actions of other participants or members of the public.
- Equipment failure.
- Theft, loss or damage to personal belongings.
- Any unforeseen hazards associated with the event or venue.

I declare that I am physically and medically fit to participate and that I have consulted a medical practitioner if necessary.

Indemnity

To the fullest extent permitted by South African law, I hereby indemnify and hold harmless Go Hiking SA, Dlala Nje, Ponte City Management and their directors, officers, employees, volunteers, guides, contractors, agents, sponsors and representatives from any claim,

demand, action, liability, loss, damage, injury, cost or expense (including legal costs) arising directly or indirectly from:

- My participation in the event;
- Personal injury;
- Illness;
- Death;
- Damage to or loss of property;
- Any act or omission by me during the event.

This indemnity applies whether the claim is brought by me, my family members, dependants, estate or any third party claiming through me, except where liability cannot legally be excluded under applicable South African law.

Medical Treatment

Should I become injured or ill during the event, I authorise the organisers to obtain emergency medical treatment on my behalf if they believe it is necessary.

I understand that any medical expenses incurred will be my sole responsibility.

Personal Property

I understand that I am solely responsible for my personal belongings and that the organisers accept no responsibility for any theft, loss or damage.

Compliance with Instructions

I agree to:

- Follow all instructions given by guides and event officials.
- Obey all safety rules.
- Respect the venue and other participants.
- Refrain from behaviour that may endanger myself or others.

I understand that failure to comply may result in my removal from the event without refund.

Photography and Media Consent

I grant Go Hiking SA, Dlala Nje and Ponte City permission to photograph or record me during the event and to use such photographs, videos or recordings for promotional, marketing, educational or social media purposes without compensation.

Personal Information

I consent to my personal information being processed for purposes related to the administration of this event in accordance with applicable South African privacy legislation.

Severability

If any provision of this indemnity is found to be invalid or unenforceable, the remaining provisions shall continue in full force and effect.
